

Tariff Inclusions

Origin tariff inclusions:

- Pre-move survey at residence
- Full export pack/wrap
- Lift van/air container if applicable
- Load into export container
- Transport from residence to port of departure
- Export customs formalities
- 50 mile service radius from city center

Freight tariff inclusions:

- Origin THC
- Ocean / Air freight
- All typical Ocean / Air carrier charges

Destination tariff inclusions:

- Customs consultation
- Import customs formalities
- Transport from port of arrival to residence
- Unload into residence
- Basic unwrap/unpack onto flat service
- Same day debris removal
- Return of empty FCL container
- DTHC / NVOCC charges if not listed separately
- 50 mile service radius from city center

All compulsory charges should be included, and no other charges will be accepted

Tariff Exclusions

OA / DA Tariff Exclusions:

- Customs duties/taxes/inspection
- Port charges
- DTHC/NVOCC charges above estimate with back up
- Demurrage/detention
- Difficult residence access
- Stair carry beyond base floor plus one
- Abnormally heavy items
- Custom crating
- Excess mileage (beyond 50 mile radius from city-center)
- Specialist/handyman services
- Other reasonable exclusions

Freight Tariff Exclusions:

- DTHC / NVOCC charges (indicate in your freight tariff if destination if THC / NVOCC charges are included)
- Port Charges
- Container Demurrage / Detention
- Customs Inspection

Key Tariff Rules

- All Air, LCL and FCL-Cased should be based on **Gross Figures** (weight / volume) – Read more about this topic at: <http://griprocure.blogspot.com/2014/11/why-gross.html>
- Weight/volume break-points apply - Read more about this topic at: <http://griprocure.blogspot.com/2013/10/breakpoints.html>
- Enter a reasonable estimate for THC / NVOCC in your tariffs. If you do not list THC / NVOCC amounts, it will be assumed that THC / NVOCC is included in your destination rates and cannot be charged as extra. Bookers may require invoice backup if THC / NVOCC is charged higher than tariff.
- Tariff rates apply up to 50 miles from city center of the market / location under which rates were filed.
- Perm Storage In/Out rates include warehouse handling
- Tariffs can be changed whenever you want, however, when a quote is booked, that quote is binding. Agents are expected to honor PricePoint quotes for at least 30 days. Beyond 30 days, validity is subject to agreement between Agent and Booker.
- US "Warehouse" Rates: If you are a non-forwarder US agent, your pricing and services should exclude port haulage, customs formalities, and freight arrangements (different from above). Warehouse rates should be filed under markets noted as "warehouse".
- Any location-specific special instructions or exceptions to these rules will be stipulated on the tariff entry screen. Please email admin@griprocure.com if you believe clarity is required for any other location-specific inclusions/exclusions.
